

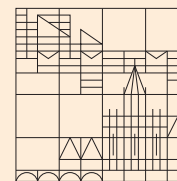

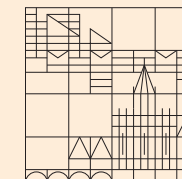

The DFG-funded interdisciplinary research group “Limits of Intentionality”, located at the University of Konstanz, aims at rethinking the fundamentals of human intentional action control on both the conceptual and the empirical level. We are especially interested in the investigation of the limits of such action control. In the interdisciplinary context of the research group, amongst others, the following topics are analysed:

- self-regulation of simple stimulus-response-processes
- relations between the control of behavior and the self-regulation of emotions in the course of (child) development
- limits of action control executed by means of implementation intentions
- limits of the self-regulation of social stereotypes and prejudice

The research group will host a summer school for master and doctoral students from 07/23/2007 to 07/27/2007 which approaches the topic “self-regulation” from the perspectives of psychology and related disciplines. International guest lecturers and members of the research group will take part in the summer school and will discuss aspects of the development of self-regulation, interference and experimental types of analysis of self-regulation. In addition to psychological paradigms and methods, approaches from philosophy and neuroscience will be considered. Participants will have extensive opportunities to present and discuss their own work in small groups with the lecturers.
