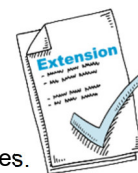


Extending the Period of Temporary Study



An extension of the temporary study visit can in general only be accepted in **exceptional** individual cases. Incoming **Erasmus+ ICM** exchange students **can not** extend their study visit after their admission letter for their study visit at the University of Konstanz was once issued. **Erasmus+** students may **not** extend from summer to winter semester!

Important

Applicants for an extension don't have any guarantee to live in a Seezeit student accommodation in the extended period. The International Office will draw lots with its remaining Seezeit rooms by the middle of December/May and inform all applicants by email. Thus, students who do not get a Seezeit accommodation have to find a place to stay on the private accommodation market without the assistance of the International Office.

Application Deadline

Please apply for the extension of the period of temporary study duly

for the next summer semester:	1 December
for the next winter semester:	1 May (not Erasmus+)

Documents needed:

For the extension of the period of temporary study (non-degree study), you have to submit the following documents:

- 1) a written permission from the **International Office** of your home university regarding the extension of your stay
- 2) filled out and signed application form »Application for Extending the Period of Temporary Study«:

- 3) current certificate of enrolment ("Immatrikulationsbescheinigung") from the University of Konstanz.

- 4) **Additionally only for free movers:** current certificate of enrolment of home university

Department

After having prepared the above mentioned documents, please visit the responsible Departmental Exchange/Erasmus+ Coordinator. Your department at the University of Konstanz must accept the extension of your study visit (2nd part of application form). Please observe the information sheet »Departmental Exchange and Erasmus+ Coordinators«.

After having it signed by the department, please visit the International Office and submit all the above mentioned documents to: Frank E. Lutzenberger; room A 614; office hours: Mon-Thu 15.00-16.00.

Extension

Please remember in this context to also extend the following:

- **Students from a non-EU/EEA country:**
The residence permit at the Foreigners' Registration Office Konstanz ("Ausländerbehörde")
Please note: You have to apply for the extension duly before the expiry of the residence permit/visa.
Please also mind the processing time.
- The health insurance policy
- The private liability insurance if applicable

Re-registration

Please keep in mind that as soon as you get your extension acknowledged you should re-register in order to continue your studies. Students registered at the University of Konstanz who wish to continue their studies in the next semester must state this **explicitly**. This statement is done through bank transfer of the required fees.

The statement for re-registration has to be done

for the next summer term:	15 January – 15 February
for the next winter term:	15 July – 15 August

Students who do not meet the deadline for paying the required fees and contributions will at first receive a (billable) reminder (15 Euro). In case there is still no payment, the student will be exmatriculated ex officio.
