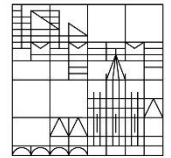

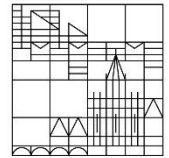

3. Purpose and legal basis for data processing

If you apply for our Senior Fellowship Programme, we will process your application data in order to contact you as well as to assess whether you have the qualifications and aptitude and fulfill the professional requirements for the position you are applying for.

Selection processes at the University of Konstanz are carried out according to the requirements determined in section 33 subsection 2 of the German Basic Law (GG), the General Act on Equal Treatment (AGG), the Act on Higher Education of the Land of Baden-Württemberg (LHG), and budgetary law.

The legal basis for data processing in the selection process for the justification of a civil servant/employment relationship is article 6 subsection 1(e) in conjunction with subsection 3 GDPR in



conjunction with section 15 of the Data Protection Act of the Land of Baden-Württemberg (LDSG) in conjunction with sections 83 to 85 of the Act on Civil Servants of the Land of Baden-Württemberg (LGB), in case of processing of special categories of personal data additionally article 9 subsection 2(b) GDPR in conjunction with section 15 subsection 2 LDSG.

4. Access to personal data

Personal data contained in the application documents are given to the members of the Executive Committee of the Zukunftscolleg, staff of the Human Resources and Financial Department of the University of Konstanz, staff representatives (Academic Staff Development, equal opportunity representative, and, if applicable, representative for employees with disabilities), Fellow(s) of the Zukunftscolleg who will act as a local host, external reviewers (peer reviewer), as well as staff of the Zukunftscolleg's Central Office.

5. Storage period

Your personal data/application documents will be destroyed within four months after receipt of a rejection, unless longer storage is necessary in order to defend legal claims. In case of successful application, your application documents will be further processed for purposes of the Senior Fellowship at the Zukunftscolleg.

6. Rights of the data subject

You have the right of access (article 15 GDPR), the right to rectification (article 16 GDPR), to erasure (article 17 GDPR), to restriction of processing (article 18 GDPR), to object (article 21 GDPR) as well as the right to data portability (article 20 GDPR).

Furthermore, you have the right to lodge a complaint with a supervisory authority according to article 51 GDPR. 7. Obligation to provide personal data

In order for the selection process to be carried out as required by law, applicants are required to provide the relevant personal data. Applicants who fail to provide the relevant personal data might not be considered for the position in question. Selection processes at the University of Konstanz are carried out according to the requirements determined in section 33 subsection 2 of the German Basic Law (GG), the General Act on Equal Treatment (AGG), the Act on Higher Education of the Land of Baden-Württemberg (LHG), and budgetary law, which dictate that candidates are selected based on qualifications, aptitude and professional requirements.
